The MESO Dimension

Meso-economic studies provide decision makers with the necessary tools for setting priorities of action and investment.

On the one hand, there are environmental damage costs at the level of a country and, on the other hand, individual expenses for environmental management at the level of a firm. What about the level of an economic sector or an urban community? Neither one – the macro - nor the other – the micro - approach highlights the status of an economic sector. For example, what is the part of transport in the national degradation of the environment? In return, what are the economic benefits for a given sector to act in favour of the environment?

The MESO programme has focused on connecting micro and macro evaluations on a middle level, the MESO level. The objective of the meso-economic studies is to seize the importance of the flows, measure them together with their transformations and impacts on the environment. Then, the consequences of these actions are translated into economic monetary terms, first into environmental degradation costs (damages and inefficiencies), second, into remediation costs. Finally, these costs are related to the value added (VA) of the concerned entity. Last, prospective scenarii are run in order to assess the evolution of environmental damage and economic inefficiencies over time.

MESO Programme in the MENA region

Since 2000, the MESO Programme promotes meso-economic studies to decision makers, industries leaders and key academia and builds further competences in environmental economics.

Different industries and services in MENA countries have been analysed in depth: cement, power generation, tourism and transport. Similarly, urban communities have also been considered: Agadir and El Jadida (Morocco), Aqaba and Irbid (Jordan) and Annaba (Algeria).

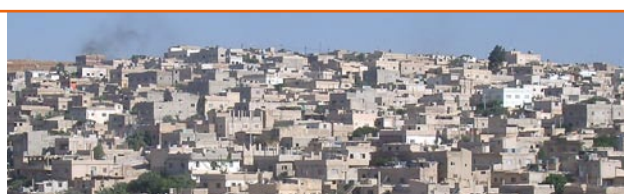
Through the MESO Programme, local competences in MENA countries have been trained and are now available either in universities or directly within key organisations and institutions.

The Ministry of Local Administration and Environment is the higher government body for legislating and promoting environment protection. The Ministry acts as the focal point for Syria for the MESO programme as it believes that environment economics can enhance a proactive approach among stakeholders.

Arab Union for Cement and Building Material (AUCBM)

AUCBM is an Inter-Arab international organization, affiliated to the General Secretariat of the Arab League and the Council of Arab Economic Unity. AUCBM aims at developing and supporting technical, industrial and commercial relations; coordinating industrial activities amongst its members; and participating in suggesting general grounds for developing industries in order to achieve technical and economical integration among Arab countries.

Its main task is to supervise and to control the productivity of the existing cement plants and executing new projects. GOCBM was the first Arab organisation in the Mashreq that finalised its MESO-economic profile. It served as a basis for deciding the main priorities for upgrading the cement sector in Syria.
